

Build4Cost 'Win house cleaning for a year or a whitegoods package' Terms & Conditions

The Promotion

1. Fill out Build4Cost one minute survey at the Home Show or online at www.build4cost.com on or before 29 October 2009 to go into the draw to win your choice of either house cleaning for a year OR a whitegoods package.

The Promoter

2. The promoter is Build4Cost (ABN 79 130 289 851) of 66 Daisy Road, Manly West, Queensland 4179.

The Prizes

3. The prize includes the winner's choice of the two following options:

(a) James' Home Services Interior Cleaning services to the value of \$2600.00 over the period of one year. The services provided are vacuuming, washing floors, clean bathroom, toilets and shower recess, polish mirrors, wipe down kitchen benches and door frame. Also provided are oven clean, wall wash, plant watering, garage clean, spring cleaning and move in or out clean. It is transferable from person to person, but is not redeemable for cash.

The prize in its entirety must be used within 12 months of the date of the voucher. James' Home Services service the Brisbane, Sunshine and Gold Coast North areas. The hinterland areas of both Sunshine and Gold Coast, and Gold Coast South are not covered.
